<b>MONETARY BAIL SCHEDULE GLADES COUNTY</b>	
Effective Date: August 1, 2009	
<b>CHARGE:</b>	<b>MONETARY BAIL:</b>
<b>A. Municipal and County Ordinances</b>	\$ 250 (cash or surety)
<b>B. Misdemeanor Criminal Traffic</b>	\$ 500 (cash or surety)
Criminal Traffic Violation Exceptions:	
DUI 1 <sup>st</sup> Offense *	\$ 750 (cash or surety)
2 <sup>nd</sup> Offense *	\$1,250 (cash or surety)
3 <sup>rd</sup> Offense *	\$5,000 (cash or surety)
*Conditions for release of persons arrested for DUI: 1. Person is no longer under the influence; 2. Person's normal faculties are no longer impaired; 3. Person's blood/breath alcohol level is lower than 0.5; 4. Eight hours have elapsed from the time of arrest.	
<b>C. Misdemeanors</b>	
Second Degree Misdemeanor *	\$ 500 (cash or surety)
First Degree Misdemeanor *	\$ 1,000 (cash or surety)
*Applies in all misdemeanor cases except those involving physical violence or domestic violence. Persons charged with a misdemeanor involving physical violence or domestic violence shall be held for the First Appearance Judge.	
<b>D. Felonies</b>	
Third Degree *	\$ 5,000 (cash or surety)
Second Degree *	\$10,000 (cash or surety)
First Degree * **	\$25,000 (cash or surety)
*If physical violence or domestic violence is involved or the defendant has a prior criminal history of felonies, the defendant shall be held for the First Appearance Judge. **If the defendant is charged with a life or capital felony, the defendant shall be held for the First Appearance Judge.	
<b>E. VOP - No bond unless set by the Court in the warrant.</b>	
<b>F. Extraordinary Circumstances</b> To deviate from this Bond Schedule, call the Duty Judge.

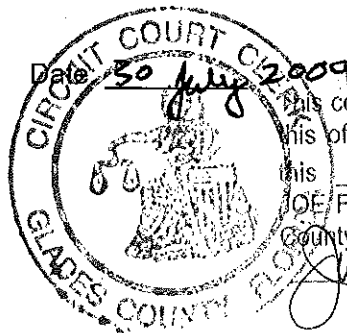
