## OUR DISTINGUISHED JUDICIAL PANEL

HON. JOHN E. DURYEA JR. is currently serving as a Lee County Judge, a position he has held since appointment by Governor Jeb Bush in 2003. He is also the County Court Administrative Judge, serving on behalf of the eight county court judges in Lee County. He received his B.A. degree from the University of South Florida and his J.D. degree from Stetson University College of Law, where he graduated, cum laude, from both institutions. He was Chief Assistant Statewide Prosecutor, a civil attorney and assistant state attorney.

HON. CYNTHIA A. ELLIS received her B.A. degree, with honors, from the University of Florida and her J.D. degree from the University of Florida. She served as assistant state attorney for both the Eighth and Twentieth Judicial Circuits, and was appointed to the position of Collier County Judge in 1989 by Governor Bob Martinez. She was then elected to her first full term in 1990. Judge Ellis was appointed by Governor Chiles to fill the Circuit Court. She began her duties on the Circuit Bench in May of 1998. Judge Ellis is currently assigned to the circuit civil docket, having been assigned to this docket in 2006. Judge Ellis served as administrative judge for Collier County from July 1, 2003 to July 1, 2005, and has been appointed to begin a second term as administrative judge for Collier County beginning July 1, 2007.

HON. JOSEPH C. FULLER received his undergraduate degree from the University of Florida. He obtained his J.D. degree from South Texas College of Law, where he graduated cum laude in 1978. Judge Fuller had an active state and federal civil trial practice from 1978 until his election to the circuit bench in November, 2006. In March 1990, he became certified as Civil County and Circuit Court Mediator and also had an active mediation practice until becoming a judge. Since assuming the bench in January 2007, he has served in the Juvenile Division as the Juvenile Delinquency Judge in Lee County and is currently assigned to the civil docket in Lee County.

HON. ALANE C. LABODA graduated from George Washington University. Judge Laboda attended the University of Miami School of Law, where she received her Juris Doctorate. From 1992 to 1997, Judge Laboda was an assistant state attorney, with the Office of the State Attorney for the Twentieth Judicial Circuit in Fort Myers, Florida. She practiced law as a stockholder with the law firm of Henderson, Franklin, Starnes & Holt, P.A. from November 1997 to August 2008, when she was appointed judge to the Circuit Court for the Twentieth Judicial Circuit by Governor Charlie Christ. Judge Laboda presently serves as a member of the Judicial Administration and Evaluation Committee for The Florida Bar.

HON. JAMES R. SHENKO was appointed by Governor Charles Crist as Circuit Court Judge for the Twentieth Judicial Circuit on July 1, 2008. Judge Shenko's current docket is domestic relations. Prior to his appointment, Judge Shenko was a solo practitioner in Fort Myers, Florida, where he practiced in the areas of mediation, guardianship, personal injury and general civil litigation. Judge Shenko received his B.A. degree, cum laude, from the University of South Florida and his J.D. degree from Florida State University College of Law.

HON. HUGH E. STARNES is a senior judge who served as Circuit Court Judge in the Twentieth Judicial Circuit from 1978 until 2008. During most of his 30 years on the bench, he served as a family judge and for four years he served as chief judge. He received the Lee County Bar Association "Liberty Bell" award, and the Young Lawyer's Division of The Florida Bar "Jurist of the Year" award in 2008.
