Misdemeanor, Criminal Traffic ²	\$500.00 per defendant for up to 5 hours; thereafter, \$75.00 per hour up to the statutory maximum*
Non-Capital, Non-Life Felonies	\$2,000.00 per defendant for up to 20 hours; thereafter, \$100.00 per hour up to the statutory maximum*
Jimmy Ryce ²	\$2,000.00 per defendant for up to 20 hours; thereafter, \$100.00 per hour up to the statutory maximum*
PBLs / Life Felonies (includes Capital Sexual Battery)	\$2,500.00 per defendant up to 20 hours; thereafter, \$100.00 per hour up to the statutory maximum*
Capital Cases/Death Penalty	\$3,500.00 per case up to 20 hours; thereafter, \$125.00 per hour ⁸ up to the statutory maximum*
V.O.P.	Juvenile Delinquency: \$500.00 per defendant ³ Misdemeanor: \$500.00 per defendant Felony: \$750.00 per defendant
Appeals/Postconvictions	\$100.00 per hour up to the statutory maximum*

Invoices billed at an hourly rate or over the statutory maximum require a court order.

Statutory Maximums pursuant to Florida Statute §27.5304(3)(2004)

Misdemeanors and Juveniles	\$1,000
Non-capital, non-life felonies:	\$2,500
Life felonies:	\$3,000
Capital cases:	\$3,500
Appeals:	\$2,000

Out-of-Circuit Travel:
