All present and future cases assigned to the Honorable Elizabeth V. Krier wherein the attorney of record is Kenneth D. Krier shall be assigned to another judge in the same division. When the Clerk reassigns a case in accordance with this Order, the clerk shall, so far as is reasonably practical, assign new cases in order to obtain an equal assignment of cases in the divisions.

All present and future cases assigned to the Honorable Joseph G. Foster wherein the attorney of record is Porter Wright shall be assigned to another judge in the same division. When the Clerk reassigns a case in accordance with this Order, the clerk shall, so far as is reasonably practical, assign new cases in order to obtain an equal assignment of cases in the divisions.

All present and future cases assigned to the Honorable Lauren L. Brodie wherein the attorney of record works in the law firm of Cummings & Lockwood LLC shall be assigned to another judge in the same division. When the Clerk reassigns a case in accordance with this Order, the clerk shall, so far as is reasonably practical, assign new cases in order to obtain an equal assignment of cases in the divisions.

In the event of reassignments, they should comply with the aforementioned conditions.
