
\*Division A will also provide additional Circuit Court support in the areas of Civil(civil abatement dockets, motions and trials)

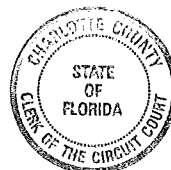
