Solicitation for Candidates for Contract to provide services as CIVIL TRAFFIC INFRACTION HEARING OFFICER

Lee and Hendry Counties

The Administrative Office of the Courts (AOC), Twentieth Judicial Circuit, is seeking an attorney, or attorneys, interested in entering into a CONTRACT with the AOC for the provision of services as a part-time Civil Traffic Infraction Hearing Officer pursuant to Fla. R. Traf. Ct. 6.630. The contractual hourly rate is \$60.00. At this time, actual part-time hours are not firmly established and may be subject to flexibility. This is NOT a solicitation for employment and no employment benefits are provided.

Minimum Requirements are:

- Juris doctorate degree from an accredited law school.
- Member in good standing with The Florida Bar for a minimum of five (5) years.
- Possesses the skills and abilities to competently perform the duties of a Civil Traffic Infraction Hearing Officer pursuant to Fla. R. Traf. Ct. 6.630.
- Has completed or will timely complete a 40-hour education and training program approved by the
 Florida Supreme Court, as is required to serve as a Civil Traffic Infraction Hearing Officer, and will
 timely complete an approved four-hour continuing education program annually, if the contract is
 extended annually.
- The ability to conform to the Code of Judicial Conduct, Canons 1, 2A, and 3, and such other provisions that might reasonably be applicable.
- If granted a contract, the contractor will not engage in any area of private practice in the Twentieth Judicial Circuit which could overlap into the areas of Civil or Criminal Traffic Court or could otherwise create any conflict or appearance of bias or impropriety.
- Ability to travel throughout the Twentieth Judicial Circuit.
