EFFECTIVE JULY 5, 2022, all Criminal Traffic Cases (CT) for Collier County currently assigned to the Honorable Blake Adams and the Honorable Tamara Lynne Nicola are to be reassigned to the Honorable Robert L. Crown, Michael Brown and Michael J. Provost in equal numbers.

FURTHER, EFFECTIVE JULY 5, 2022, all Civil Traffic (TR) for Collier County currently assigned to the Honorable Blake Adams and the Honorable Tamara Lynne Nicola are to be reassigned to the Honorable Robert L. Crown, Michael Brown and Michael J. Provost in equal numbers.

FURTHER, EFFECTIVE JULY 5, 2022, all Ordinance Cases (CO) for Collier County currently assigned to the Honorable Blake Adams and the Honorable Tamara Lynne Nicola are to be reassigned to the Honorable Robert L. Crown, Michael Brown and Michael J. Provost in equal numbers.

FURTHER, EFFECTIVE JULY 5, 2022, all County Civil Cases (CC) for Collier County currently assigned to the Honorable Robert L. Crown, Michael Brown and Michael J. Provost are to be reassigned to the Honorable Blake Adams and the Honorable Tamara Lynne Nicola in equal numbers. Thereafter, the Clerk shall reassign all pending County Civil Cases (CC) that are currently assigned to the Honorable Janeice T. Martin in equal numbers to the Honorable Blake Adams and the Honorable Tamara Lynne Nicola as is necessary to bring Judges Adams and Nicola up to 33%, and Judge Martin down to 33%, of all pending County Civil Cases as a result of this reassignment. In doing so, the Clerk shall endeavor, to the extent possible, to reassign only those Martin cases that do not currently have a pending court date. However, if necessary to bring the three caseloads to 33% each, the Clerk may reassign even those cases that have a pending court date with Judge Martin.

FURTHER, EFFECTIVE JULY 5, 2022, all Small Claims Cases (SC) for Collier County currently assigned to the Honorable Robert L. Crown, Michael Brown and Michael J. Provost are to be reassigned to the Honorable Blake Adams, the Honorable Tamara Lynne Nicola, and the Honorable Janeice T. Martin such that Judges Adams, Nicola and Martin will each have 33% of the pending Small Claims Cases for Collier County as a result of this reassignment. In doing so, the Clerk will note that Judges Adams and Nicola previously had a

20% share of these cases, and they will thus keep those cases already assigned to them, and receive a smaller proportionate share of the newly reassigned cases than Judge Martin will, who previously had 0% of these cases.

FURTHER, EFFECTIVE JULY 5, 2022, all Infraction Cases (IN) for Collier County currently assigned to the Honorable Robert L. Crown, Michael Brown and Michael J. Provost are to be reassigned to the Honorable Blake Adams, the Honorable Tamara Lynne Nicola, and the Honorable Janeice T. Martin such that Judges Adams, Nicola and Martin will each have 33% of the pending Infraction Cases for Collier County as a result of this reassignment. In doing so, the Clerk will note that Judges Adams and Nicola previously had a 20% share of these cases, and they will thus keep those cases already assigned to them, and receive a smaller proportionate share of the newly reassigned cases than Judge Martin will, who previously had 0% of these cases.

FURTHER, EFFECTIVE JULY 5, 2022, all Municipal Ordinance Cases (MO) for Collier County currently assigned to the Honorable Robert L. Crown, Michael Brown and Michael J. Provost are to be reassigned to the Honorable Blake Adams, the Honorable Tamara Lynne Nicola, and the Honorable Janeice T. Martin such that Judges Adams, Nicola and Martin will each have 33% of the pending Municipal Ordinance Cases for Collier County as a result of this reassignment. In doing so, the Clerk will note that Judges Adams and Nicola previously had a 20% share of these cases, and they will thus keep those cases already assigned to them, and receive a smaller proportionate share of the newly reassigned cases than Judge Martin will, who previously had 0% of these cases.
