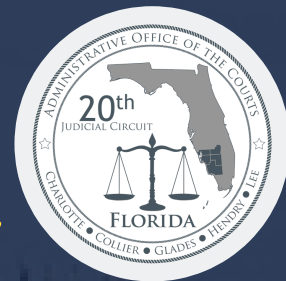

INVESTITURE OF JUDGE MICHAEL POWELL

Judge Michael Powell was formally invested as a Charlotte County Judge during a ceremony held on Friday, August 8, 2025 at the Charlotte County Courthouse. The event brought together members of the judiciary, local bar leaders, elected officials, colleagues, family, and friends to mark this significant milestone in Judge Powell's judicial career.

Chief Judge J. Frank Porter presided over the ceremony, which opened with the Charlotte County Sheriff's Office Color Guard and the Pledge of Allegiance led by Judge Powell's children, Jacob and Ainsley.

The ceremony featured remarks from guest speakers who shared professional and personal reflections on Judge Powell's career. Attorney Drew Fritsch and retired attorney Mark Desisto offered insight into his dedication to the practice of law.

Charlotte County Judge John Burns, a longtime colleague and friend, spoke about Judge Powell's character and the values he brings to the bench. "He's a good husband. A good father. A good friend. He's a good person. That's why I know he'll be a good judge," Judge Burns said. "It's an honor that I get to be here today to give a glimpse into our personal relationship that demonstrates who Mike is."

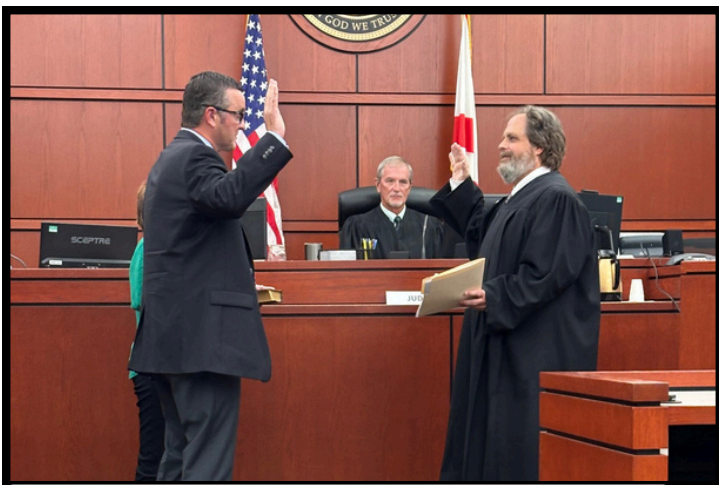

Guest speakers included State Attorney Amira Fox and Chief Assistant State Attorney Richard Montecalvo, who shared reflections on Judge Stewart's career and character. Speaking about her years working alongside Judge Stewart at the State Attorney's Office, Judge Cunningham highlighted his professionalism and compassion.

"James always handled each situation with stride, and I was always impressed with his interaction with victims," said Judge Cunningham. "He listened to their concerns and frustrations so they felt like they had a voice and that their voice was being heard, much like he does on the bench."

INVESTITURE OF JUDGE AMANDA LEVY-REIS

A packed courtroom gathered to celebrate the Investiture of Circuit Judge Amanda Levy-Reis at the Collier County Courthouse on November 7, 2025.

The ceremony was presided over by Deputy Chief Judge Joseph Foster and opened with a presentation of the Colors by the Collier County Sheriff's Office Honor Guard. The Naples Performing Arts Center All Stars led the Pledge of Allegiance and performed God Bless America, setting a respectful and celebratory tone for the proceedings. Pastor Jeremiah Taylor delivered the invocation, followed by introductions of judges, magistrates, judicial staff, and distinguished guests in attendance.

Guest speakers reflected on her professionalism, integrity, and deep connection to the community she now serves from the bench.

U.S. Magistrate Judge Helena Barch-Kuchta, who worked closely with Judge Levy-Reis earlier in her legal career, spoke to both her qualifications and character.

"You've done this the right way, for the right reasons and in the right place... your own hometown," said Judge Barch-Kuchta. "Your community is lucky to have you. I am proud to call you a colleague and a Judge."

INVESTITURE OF JUDGE TRENT REICHLING

The Investiture of Circuit Judge Trent Reichling was held on December 5, 2025 at the Lee County Justice Center. The courtroom was filled with judges from across the circuit and beyond, members of the legal community, family, and friends who gathered to recognize him.

Chief Judge J. Frank Porter presided over the ceremony, which included an Honor Guard presentation, the Pledge of Allegiance, and the introduction of judges, magistrates, judicial assistants, and dignitaries in attendance.

Before taking the bench, Judge Reichling dedicated a combined 14 years to public service as both a state and federal prosecutor. His career included service as an Assistant State Attorney at the Miami-Dade State Attorney's Office, a Special Assistant United States Attorney with the United States Attorney's Office for the Southern District of Florida, and most recently as an Assistant United States Attorney with the Middle District of Florida in the Fort Myers Division.

Several speakers shared remarks highlighting Judge Reichling's professionalism, work ethic, and commitment to justice. Among them was the Honorable Thomas P. Barber, United States District Judge for the Middle District of Florida, who told us multiple reasons why he believes Judge Reichling will be a great judge. "Trent will be a judicial colleague that looks out for his fellow judges and elevates everyone, not just himself," said Judge Barber.

Judge Sheri Polster Chappell administered the oath of office while Judge Reichling's mother held the Bible. His wife then assisted with the enrobing.

In his remarks, Judge Reichling expressed gratitude to his family, mentors, and colleagues, and also shared his commitment to those who will appear before him. "As I embark upon my career as a judge I can promise you all this, whenever you are in my courtroom you will always be treated with respect, the law will be followed, fairness will be guaranteed, and humor will be sprinkled in to add levity," Judge Reichling said.

Circuit Judge Lauren Brodie was honored by Legal Aid Service of Collier County with the 2025 Cathy Lucrezi Excellence in Public Service Award at the organization's Impact Awards Luncheon on November 20, 2025.

Named in memory of the late Cathy Lucrezi, the award recognizes individuals who demonstrate a lifelong commitment to public service and whose work has made a lasting impact on the local community. Judge Brodie's decades of service to the judiciary and the citizens of Southwest Florida reflect these values wholeheartedly.

Throughout her distinguished career, Judge Brodie has served in numerous judicial roles across Florida, contributed extensively to judicial education, mentored new judges, and been recognized with multiple statewide honors, including:

- 2022 William M. Hoeveler Judicial Professionalism Award
- 2007 Florida Supreme Court Chief Justice's Distinguished Service Award
- 2015 Woman Lawyer of the Year by the Collier County Women's Bar Association

JUDGE MANALICH NAMED JURIST OF THE YEAR



The Southwest Florida American Board of Trial Advocates (ABOTA) hosted its Annual Judicial Appreciation Dinner and Award Ceremony, honoring the hard work and dedication of our local judges.

A highlight of the event was the presentation of the Jurist of the Year Award to the Honorable Ramiro Manalich. This distinction recognizes a judge who exemplifies fairness, professionalism, and dedication to the administration of justice. Judge Manalich was honored for his continued commitment to the highest standards of the judiciary and his positive impact on the legal community.



The annual Judicial Appreciation Dinner serves as an opportunity for ABOTA to strengthen the relationship between the bench and the bar while celebrating excellence within the courts. Through recognition of judges who demonstrate outstanding leadership and integrity, ABOTA seeks to foster the improvement of ethical and technical standards in advocacy to better serve litigants.

CHARLOTTE COUNTY LAUNCHES VETERANS COURT

In October 2025, the Charlotte County Veterans Treatment Court officially welcomed its first participants.

Presided over by Judge Sean Lux, Veterans Treatment Court supports veterans and service members facing mental health or substance use challenges as they navigate the justice system. The program focuses on accountability paired with treatment, which connects participants to individualized treatment plans and resources that support employment, education, housing, and long-term stability while strengthening public safety.

Veterans Day week was an especially meaningful moment for the program, as six veterans appeared in Veterans Treatment Court to continue their journey of growth and recovery.

As participants progress through the program, Judge Lux presents them with dog tags representing a stage of achievement and advancement.

Judge Lux's commitment to veterans extends beyond the courtroom. He is also the founder and director of the Collier-Lee Honor Flight, an organization that brings veterans to Washington, D.C. to visit the memorials dedicated to honoring their service.

Veterans Treatment Court is supported by a dedicated team with strong ties to military service. Treatment Courts Coordinator Paul Martineau and Mentor Coordinator Nikki DiPaola are both veterans of the United States Marine Corps, bringing firsthand experience and empathy to the veterans they serve.

Special thanks are extended to Steven Woodberry from the Public Defender's Office, Assistant State Attorney Cindy Rebholz-Rubin, Assistant Public Defender Cameron Rhoad, and the potential mentors whose efforts helped bring the Veterans Treatment Court to Charlotte County.

HONORING SERVICE AND SECOND CHANCES

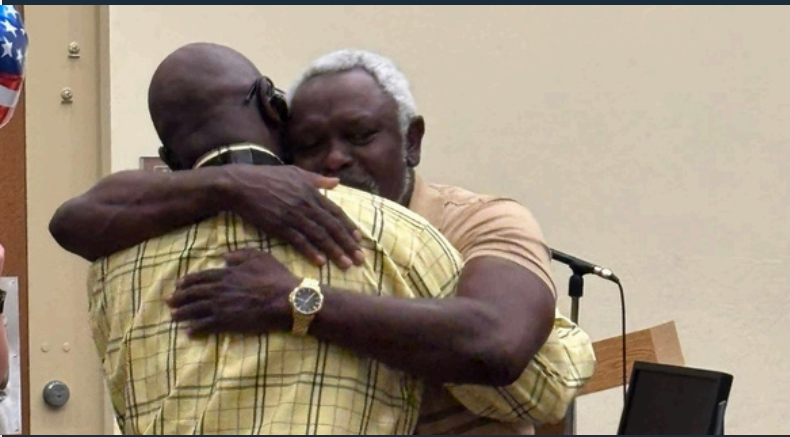
Lee County Veterans Treatment Court celebrated Veterans Day with three inspiring graduations!

Also in attendance were our Veterans' Court Mentors, other recent graduates, and our community partners.



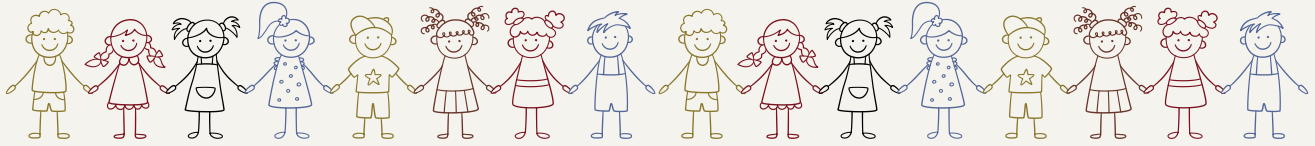

Southwest Florida celebrated an unforgettable National Adoption Month in November 2025.

The Children's Network of Southwest Florida hosted two mass adoption hearings during National Adoption Month, where more than two dozen children officially joined their forever families.

On Friday, November 21, Judge Elizabeth Krier finalized 12 adoptions at the Collier County Courthouse. The celebration continued the next morning in Lee County, where Judge Tracey Redd finalized 13 more adoptions.

These events honor National Adoption Month and National Adoption Day, which shines a light on the children in our local foster care system and the dedicated teams who support them.

CNSWFL CEO Nadereh Salim shared her excitement, noting the teamwork and heart that make these moments possible.

Collier County Teen Court Community Outreach Event

In July the Collier County Teen Court partnered with the Naples Police Department to simulate court-related scenarios for the Soaring Eagles Youth Leadership Academy.

The Teen Court Team for this event consisted of Administrative Office of the Courts Intern and Teen Court Volunteer, Rita Echevarria-Fuego, Andrew McGann Esq. Acting as Judge, Program Specialist Jorge Velarde and Volunteer Prosecutor, Dasha Voit.

Teen Court Volunteers worked with the directors of the Soaring Eagles Program for over a year preparing for the event. There were two staged crimes and a mock trial. The day started off with two crimes being reenacted, a grand theft auto, and an auto burglary.

The Leadership Academy students were separated into two groups, witnessed the crimes being committed, then they were asked to give statements on what they saw. One group saw a picture lineup and was tasked with choosing the person who they felt committed the crime. The other group viewed a line- up of possible suspects. The students walked up to each suspect and gave a percentage of how certain they were of the identity of the criminal.

Teen Court attorneys for the prosecution and defense then interviewed witnesses, Police Officers, and the defendants. The attorneys then used their testimony in the Mock Trial.

The cases were handled as they would be for an actual court proceeding. The Teen Court Team prepared the witnesses and their questions, opening statements and closing arguments. Then came the demonstration; there were objections, redirects, and passionate rebuttals. The Leadership Academy students were shown video footage, and the picture lineup. The students were very engaged and had many pertinent questions.

Collier's Teen Court Program wishes to thank the Naples Police Department and will continue to partner with local agencies to promote awareness and responsible behavior for the citizens of Collier County.

Their commitment to effective and innovative solutions highlights the importance of ADR within our trial court system and strengthens access to justice for all.

Digital Court Reporting Week

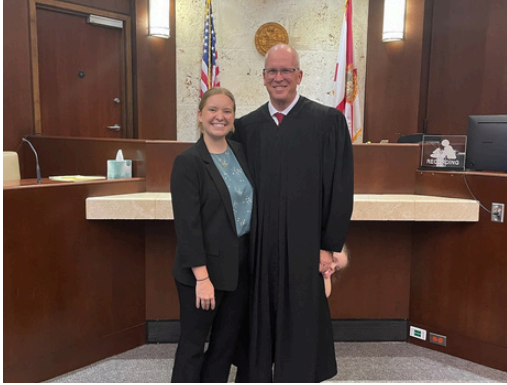

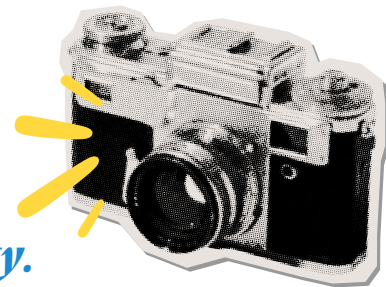
Judge Blake Adams had the privilege of administering the oath of admission to the Florida Bar to his former law student intern,

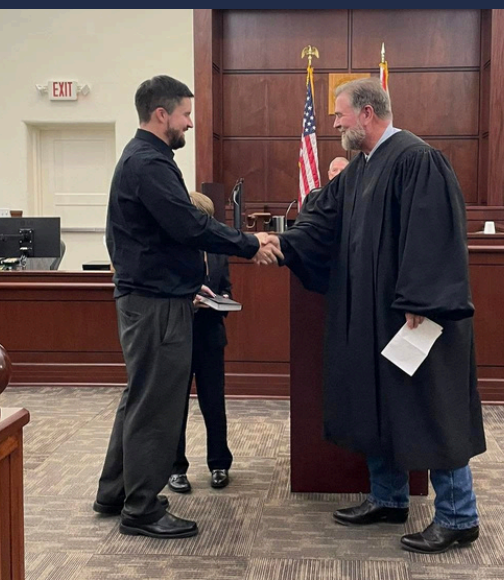
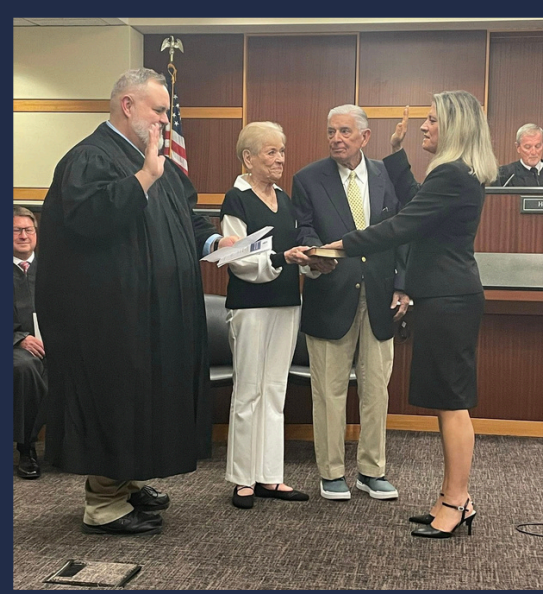
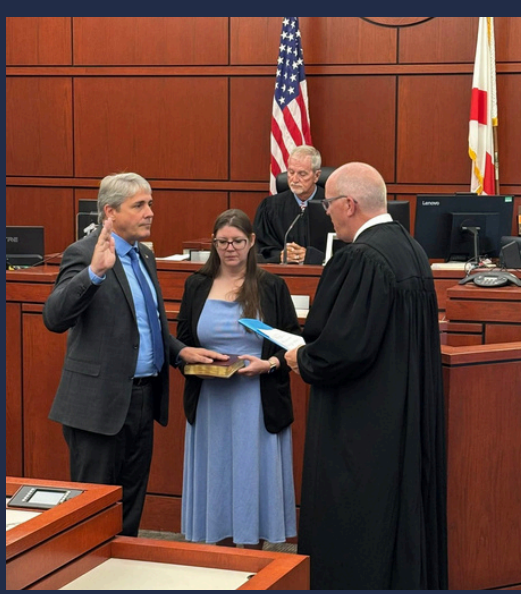
