WHEREAS, in order to expedite the administration of justice in the Twentieth Judicial Circuit, and

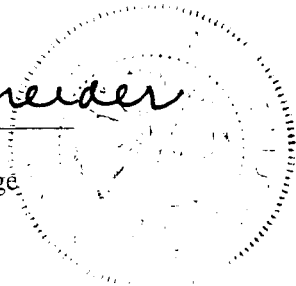

THIS ORDER shall remain in effect until amended, terminated or revoked by subsequent Order of the Court.

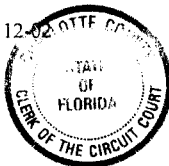

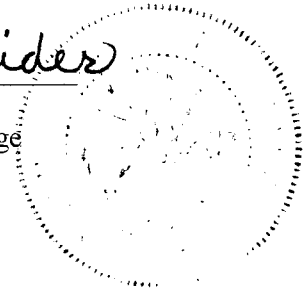

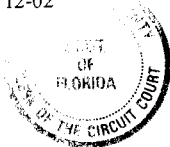
