As provided in Florida Statute § 61.1824, the Court recognizes that the State Disbursement Unit ("SDU") of the Florida Department of Revenue ("DOR") is responsible for the collection and disbursement of payments for all child support cases enforced by DOR pursuant to Title IV-D of the Social Security Act; as well as all child support cases not being enforced by the DOR pursuant to Title IV-D of the Social Security Act in which the initial support order was issued in this state on or after January 1, 1994 and in which the obligor's child support obligation is being paid through an income deduction order.

The Court also recognizes that pursuant to the contract between the Florida Association of Court Clerks, Inc. and Lockheed Martin IMS Corporation ("LMIMS") dated August 17, 1999, LMIMS is responsible for the operation of a Centralized Disbursement Unit for processing private cases in which support payments for child support and alimony cases are not processed through the SDU.

Private cases include cases not being enforced by the Department of Revenue pursuant to Title IV-D of the Social Security Act in which the initial support order was issued in this state prior to January 1, 1994 and in which the obligor's child support obligation is being paid through an income deduction order, and all non-Title IV-D cases not subject to income deduction orders.

With the foregoing in mind, and in accordance with Fla. Fam. L. R. P. 12.750 and Fla. R. Jud. Admin. 2.050, it is ordered and adjudged as follows:

The Clerks of the Circuit Courts for Charlotte, Hendry, and Lee Counties will no longer accept child support payments, with the exception of court-ordered purge and cash payments. Instead, child support payments in those counties are to be sent to the following address:

A voice response unit ("VRU") is available toll free at 1-877-769-0251. The VRU is available for general payment information about child support collections and payments. In addition, each Clerk of the Circuit Court can provide a payment history.

The Clerks of the Circuit Courts in Collier and Glades Counties will continue to accept child support payments in private cases. However, all other child support payments in those counties are to be sent to the SDU at the address listed above.


