ADMINISTRATIVE ORDER
NO. 2.34
- Amended -

In recognition of the fact that the courts of the State of Florida have an inherent interest in promoting and encouraging professionalism within the legal community; and in further recognition of the fact that, in 1998, the Twentieth Judicial Circuit's Professionalism Committee was initially formed as provided for by the Supreme Court of Florida's Administrative Order *In re: Commission on Professionalism* dated June 11, 1998; and in further recognition of the fact that in recent years, the Twentieth Judicial Circuit's Professionalism Committee has been superseded by the professionalism efforts and activities on the part of our local bar associations, it is

ORDERED that, in accordance with the authority vested in the Chief Judge pursuant to Fla. R. Jud. Admin. 2.215, and the Supreme Court of Florida's Administrative Order *In re: Commission on Professionalism* dated June 11, 1998:

1. The Twentieth Judicial Circuit Professionalism Committee is hereby re-established.
2. The Twentieth Judicial Circuit Professionalism Committee shall consist of the following members:

- a. The Chief Judge – Chair
- b. The Circuit Administrative Judge (or Deputy Chief Judge) for Lee County
- c. The Circuit Administrative Judge for Collier County
- d. The Circuit Administrative Judge for Charlotte County
- e. The Administrative Judge for Hendry County
- f. The Administrative Judge for Glades County
- g. The President of the Lee County Bar Association, or designee
- h. The President of the Collier County Bar Association, or designee
- i. The President of the Charlotte County Bar Association, or designee
- j. The President of the Hendry/Glades Counties Bar Association, or designee
- k. The Twentieth Judicial Circuit State Attorney, or designee
- l. The Twentieth Judicial Circuit Public Defender, or designee
- m. The Second District Criminal Conflict and Civil Regional Counsel, or designee
- n. The President of the Calusa American Inn of Court, or designee
- o. The President of the Thomas S. Biggs American Inn of Court, or designee
- p. At-large member – a practicing attorney to be appointed by the Chief Judge

3. Each member shall serve during that member's term of office. The at-large member shall serve at the pleasure of the Chief Judge and shall serve during the Chief Judge's term of office, unless otherwise discharged by the Chief Judge.


4. The Twentieth Judicial Circuit Professionalism Committee shall meet quarterly, or on a schedule otherwise established by the Committee.

5. The Twentieth Judicial Circuit Professionalism Committee shall discuss, monitor and/or coordinate professionalism activities within the Twentieth Judicial Circuit, and may take action deemed appropriate by the Committee in furtherance of promoting and encouraging professionalism within the legal community.

6. Each January, the Twentieth Judicial Circuit Professionalism Committee shall submit to the Chair of the Commission on Professionalism an annual report on the status of professionalism and professionalism activities within the Twentieth Judicial Circuit.

7. To the extent that any provision of this Administrative Order may be construed as being in conflict with any law, statute, or rule, the law, statute, or rule shall prevail.

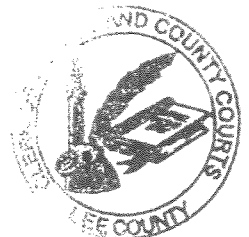
