ADMINISTRATIVE ORDER  
NO: 6.4

Pursuant to Florida Statute § 316.613(5), and this Court's authority to promote the uniform administration of justice throughout the Twentieth Judicial Circuit Court as prescribed by Fla. R. Jud. Admin. 2.050, the Court hereby establishes a Child Restraint Safety Program throughout the Twentieth Judicial Circuit Court.


The following procedures shall be used to implement the Child Restraint Safety Program:

1. The Clerks of the circuit courts throughout the Twentieth Judicial Circuit shall provide an Alternative Sentence Affidavit for persons charged with a child restraint violation.
2. If the offender elects to attend the program, each Clerk of the circuit court shall collect from each offender such fees as are authorized by state and local law.
3. The child restraint safety program classes will be given by the Southwest Florida Safety Council Inc. and a charge of \$20.00 is hereby authorized for attendance at the class.

In accordance with the statute cited above, the Court hereby approves of the program which has been established and will be operated by the Southwest Florida Safety Council Inc. The Southwest Florida Safety Council Inc. shall notify the Clerks of the Courts of either the successful completion of the program by each offender or the offender's failure to complete the program.

Upon notification of the successful completion of the program, the penalty specified in Chapter 318 and any associated costs shall be waived and the assessment of points shall also be waived. In the event that the offender fails to complete the program, the Clerks of the Courts are hereby authorized to D-6 the license and levy the original fines, costs and fees on any such offender.
