The Chairperson of the Peer Review Committee shall be Jason H. Korn of Naples, the Vice-Chair shall be Steven Kushner of Fort Myers and the Secretary shall be Julie Osterhout of Fort Myers.

The terms of these officers shall extend from July 1, 2000 through June 30, 2001. On or prior to the expiration of that term, the committee shall meet and elect new officers or extend the terms of these officers as the committee deems appropriate.

In the event that any member of the Peer Review Committee fails to demonstrate a sufficient interest in the committee or to otherwise carry out his or her duties on a regular basis, then they may be subject to removal and replacement in accordance with paragraph IV.A. of the Peer Review Program.

The lawyers appointed to serve on the committee shall serve a two year term, which may be extended by further order of this court in accordance with Administrative Order 2.20. This order shall remain in effect until further order of this Court.
