WHEREAS, there are legitimate security and public safety concerns with transporting jail inmates and juvenile detainees to the Collier County Courthouse for the purpose of taking discovery depositions pursuant to Fla. R. Crim. P. 3.220,

IT IS HEREBY ORDERED, pursuant to the authority provided by Fla. R. Jud. Admin. 2.050 and Fla. R. Crim. P. 3.220(h)(3) as follows:

- (1) Discovery depositions of Collier County Jail inmates or detainees shall be taken at the Collier County Jail, providing that the Collier County Jail has deposition facilities available that can adequately provide for all parties' safety and privacy concerns.
- (2) Discovery depositions of juvenile detainees held at the Department of Juvenile Justice Holding Facility in Collier County shall be taken at the Department of Juvenile Justice Holding Facility in Collier County, providing that the Holding Facility has deposition facilities available that can adequately provide for all parties' safety and privacy concerns.
- (3) In any particular case, if any party has an objection to a deposition being taken at the Collier County Jail or Department of Juvenile Justice Holding Facility, that party may file an objection or motion with the trial court seeking a determination as to where the deposition shall be taken.
- (4) This order is not intended to divest the trial court of its authority under Fla. R. Crim. P. 3.220(h)(3) to designate a location for the taking of a deposition, and is not intended to divest the parties of their right under Fla. R. Crim. P. 3.220(h)(3) to agree upon a location for the taking of a deposition.
