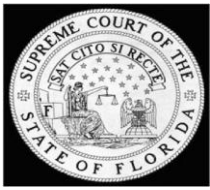
List of Certified Process Servers

The Twentieth Judicial Circuit of Florida established, via Administrative Order 2.30, this approved list of Certified Process Servers as an alternative means for the service of process for criminal summonses, criminal witness subpoenas, and initial nonenforceable civil process. While this list represents persons who have been authorized to serve state-court process within the circuit, this list must not, as per section 48.27, Florida Statutes, be used to exclude a person from equally authorized appointments in accordance with Rule 1.070(b) of the Florida Rules of Civil Procedure (which are accomplished by case-by-case motions and orders) or section 48.021, Florida Statutes. In sum, this list does not represent any exclusive form of authorization to serve process within the circuit under either state, federal, or any other authority provided for by law.
