**MISDEMEANOR DIVERSION PROGRAM INFORMATION SHEET**

A **\$150.00 supervision** fee and a **\$50.00 prosecution fee** must be paid after 10 days, but within 90 days, of signing the Deferred Prosecution Agreement. The payment must be made payable to **Lee County Clerk of the Court (COS-PTD, COP-PTD)** in the form of a money order or cashier's check. The name and case number (s) must be included.

Pursuant to Florida Statute §27.52, if the defendant has applied for the services of the Public Defender, a **\$50 application fee** must be paid within 7 days to **Lee County Clerk of the Court** in the form of a money order or cashier's check. The Public Defender's office may be contacted at (239) 533-2911.

Fees can be paid at the Lee County Clerk of the Court on the 1<sup>st</sup> floor of the Justice Center in the form of cash, credit card, debit card, money order or cashier's check, or can be mailed to: **Lee County Clerk of Court P.O. Box 2507 Ft. Myers, FL 33902**
