

Twentieth Judicial Circuit Vehicle Immobilization for Lee County Sec. 316.193, Florida Statutes



Court-Ordered Impoundment or Immobilization as Related to County Court DUI Convictions

As the result of convictions for drinking and driving, or driving while license suspended/revoked, the judge may order the vehicle being driven, (even if owned by a third party) immobilized for a period of time. If your vehicle was ordered immobilized, you must contact an approved immobilization service and make arrangements to have the vehicle secured, so it cannot be driven during the period of immobilization.

It is your responsibility to have the immobilization devise placed on the vehicle, pay the appropriate fee, and report to the court that this has occurred, prior to the date on the order.

Failure to comply with an immobilization order may result in a warrant for your arrest and/or an order of impound being issued. If an order of impound is issued, police officers will locate the vehicle and have the vehicle towed and then stored at an impound lot for the immobilization period. This is at the owners risk and expense.
